### WHO SHALL FILE:

All public officials and employees, except those who serve in an honorary capacity, laborers and casual or temporary workers, shall file under oath their Statement of Assets, Liabilities and Net Worth and a Disclosure of Business Interests and Financial Connections and those of their spouses and unmarried children under eighteen (18) years of age living in their households.

#### WHEN TO FILE:

- 1. Within thirty (30) days after assumption of office, statements of which must be reckoned as of his first day of service;
- 2. On or before April 30 of every year thereafter, statements of which must be reckoned as of the end of the preceding year, or,
- 3. Within thirty (30) days after separation from the service, statement of which must be reckoned as of his last day of office.

## WHAT IS THE PENALTY FOR NON-FILING OF SALN AND DBIFC:

Under Section 11 of RA 6713, imprisonment not exceeds five (5) years, or a fine not exceeding Five Thousand Pesos (P5,000.00), or both, and, in the discretion of court of competent jurisdiction, and disqualification to hold public office.
